Week ending June 16, 2023

After raising the Fed Funds interest rate by 500 basis points over the past year, the Federal Reserve left the rate unchanged at their FOMC meeting last week. While the pause was widely expected, comments from the Fed Chairman and the accompanying statement indicate that future rate hikes are possible but will depend on the incoming data. The current projections are for two potential rate hikes of 25 basis points each. Last week's economic data continues to support the Fed's goals as the headline Consumer Price Index came in at 4% for May, down from 4.9% in April and reaching a new 2 year low.

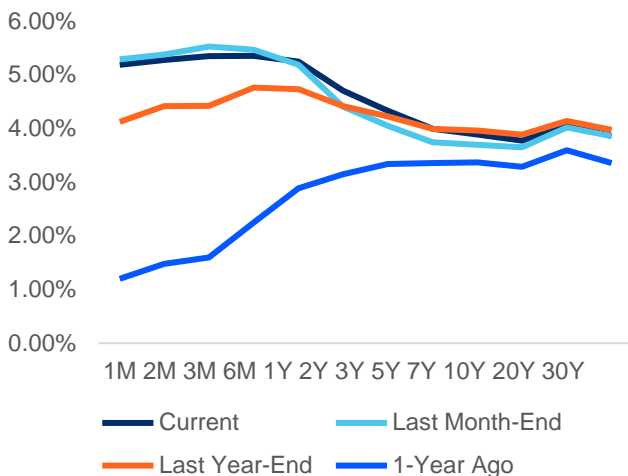
Fixed Income Markets Overview

- Rates were relatively unchanged this week following the Fed's announcement.
- The European Central Bank did raise their key rate this week by 25 basis points, while the Bank of Japan opted to not move their rates. ECB leader Lagarde indicated that future hikes are likely due to continued inflationary pressure.
- Other economic data included a declining Producer Price Index coming in at 0.3% in May while retail sales surprised to the upside at 0.3% for the month.
- The University of Michigan Consumer Confidence Index beat expectations coming in at 63.9 versus expectations of 60.2.

Equity Markets Overview

- All three major equity indices were up for the week, led by the NASDAQ (+3.2%).
- The S&P 500 had its best week of the year (+2.6%). For the year to date, the index is up 15.8%
- A majority of the S&P 500 sectors were positive for the week, led by Information Technology (+4.4%) and Materials (+3.2%). The only negative sector was Energy (-0.7%).
- Stocks in the news last week included Oracle Corp and Adobe, which both reported earnings that beat expectations.

MSCI Emerging Markets Index captures large and mid-cap representation across 24 Emerging Markets (EM) countries.

S&P GSCI is broad-based and production weighted to represent the global commodity market beta. The index is designed to be investable by including the most liquid commodity futures.

S&P GSCI Gold a sub-index of the S&P GSCI, provides investors with a reliable and publicly available benchmark tracking the COMEX gold future.

Bloomberg Barclays U.S. Aggregate Bond Index represents securities that are SEC-registered, taxable, and dollar denominated. The index covers the U.S. investment grade fixed rate bond market, with index components for government and corporate securities, mortgage pass-through securities, and asset-backed securities.

Bloomberg Barclays U.S. Treasury Aggregate Bond Index is the U.S. Treasury component of the U.S. Government index and represents public obligations of the U.S. Treasury with a remaining maturity of one year or more.

Bloomberg US TIPS Index consists of Inflation-Protection securities issued by the U.S. Treasury.

Bloomberg Barclays US Corporate Bond Index is the Corporate component of the U.S. Credit index and represents publicly issued U.S. corporate and specified foreign debentures and secured notes that meet the specified maturity, liquidity, and quality requirements.

Bloomberg Barclays U.S. Corporate High Yield Index covers the universe of fixed rate, non-investment grade debt.

Bloomberg Barclays Emerging Markets Bond Index is broad-based with country eligibility and classification as an Emerging Market being rules-based and reviewed on an annual basis using World Bank income group and International Monetary Fund (IMF) country classifications.

Bloomberg Barclays U.S. Municipal Index is a rules-based, market-value-weighted index engineered for the long-term tax-exempt bond market.

Bloomberg Barclays US High Yield Municipal Index is an unmanaged index of noninvestment-grade municipal debt securities, which provides a representation of the performance of US high-yield tax-exempt bonds.

Federal Funds Rate is the interest rate at which depository institutions trade federal funds (balances held at Federal Reserve Banks) with each other overnight.
