Week ending July 7, 2023

Is the labor market softening? This week's non-farm payroll report came in below expectations with a gain of 209,000 jobs versus expectations of 230,000. While still a strong number, it does mark the lowest job gain since December 2020. Other signs of a labor market slowdown this week included higher weekly jobless claims and a decrease in the number of job openings. One key item from the NFP report was the continuing pressure on wages as the average hourly wage gain was up more than expected at a 4.4% annual rate.

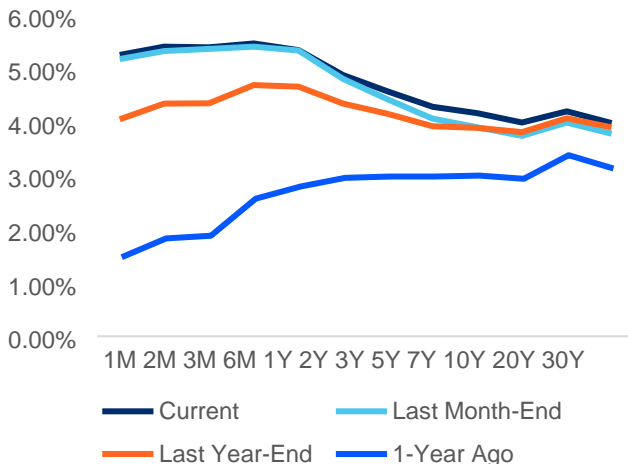
Fixed Income Markets Overview

- Bond yields were up this week with the 2-year U.S. Treasury breaking above 5.0% on Thursday before pulling back to close the week.
- The release of the minutes from the June FOMC meeting revealed that a majority of the FOMC members believe there will be a need for future rate hikes.
- Some economic reports this week continue to paint a mixed picture of the economy. The ISM non-manufacturing report showed strength in the service sector with a reading of 53.9, while the manufacturing sector report continues to decline, falling below expectations in June, with a contractionary reading of 46.0.
- As of Friday, the market was pricing in a 92.4% expectation of a 25-basis point rate hike at the July FOMC meeting according to CME FedWatch Tool.

- Second quarter earnings reports will start this week with reports scheduled from PepsiCo, Delta Airlines, and JPMorgan Chase among others.
- Stocks in the news this week included Levi Strauss who slashed guidance for the remainder of the year, while biotechnology company Biogen received approval from the FDA for their Alzheimer's drug Lequemb.

Bloomberg Barclays Emerging Markets Bond Index is broad-based with country eligibility and classification as an Emerging Market being rules-based and reviewed on an annual basis using World Bank income group and International Monetary Fund (IMF) country classifications.

Bloomberg Barclays U.S. Municipal Index is a rules-based, market-value-weighted index engineered for the long-term tax-exempt bond market.

Bloomberg Barclays US High Yield Municipal Index is an unmanaged index of noninvestment-grade municipal debt securities, which provides a representation of the performance of US high-yield tax-exempt bonds.
