Week ending August 11, 2023

The inflation reports of the past week painted a mixed picture for investors. The Consumer Price Index (CPI) came in line with expectations with a year over year increase of 3.2%. The core CPI figure, which excludes food and energy, was up 4.7% on an annual basis and unchanged for the month. All these readings reflected moderating levels of pricing pressure. However, at the wholesale level, the Producer Price Index (PPI) came in higher than expected at 0.8% for the month. Another key release this past week included the University of Michigan Consumer Sentiment Index which fell slightly from last month's reading. However, the current level remains well above the reading of one year ago.

Fixed Income Markets Overview

- Treasuries reached their high for the week on Friday following the PPI report.
- The rating agencies were in the news again this week. This time it was Moody's who downgraded the credit of ten small and mid-size banks based on concerns that the current financial strains "could erode their profitability."

Equity Markets Overview

- It was a mixed week for the major equity indices with Dow Jones up slightly, +0.6%, while both the Nasdaq, -1.9%, and the S&P, -0.3%, fell.
- The equity sectors were also mixed for the week.
 Energy lead the group rising +3.6% followed by
 Healthcare at +2.5%. Information Technology was the hardest hit sector falling -2.8% followed by
 Consumer Discretionary at -1.0%.
- In earnings news this week, Disney reported mixed results citing success at theme parks but pressure in their streaming business. Sony reported a drop in operating income but increased their forecast for the rest of the year. Drug maker Eli Lilly also raised their guidance for the remainder of 2023.

Bloomberg Barclays U.S. Aggregate Bond Index represents securities that are SECregistered, taxable, and dollar denominated. The index covers the U.S. investment grade fixed rate bond market, with index components for government and corporate securities, mortgage pass-through securities, and asset-backed securities.

Bloomberg Barclays U.S. Treasury Aggregate Bond Index is the U.S. Treasury component of the U.S. Government index and represents public obligations of the U.S. Treasury with a remaining maturity of one year or more.

Bloomberg US TIPS Index consists of Inflation-Protection securities issued by the U.S. Treasury.

Bloomberg Barclays US Corporate Bond Index is the Corporate component of the U.S. Credit index and represents publicly issued U.S. corporate and specified foreign debentures and secured notes that meet the specified maturity, liquidity, and quality requirements.

Bloomberg Barclays U.S. Corporate High Yield Index covers the universe of fixed rate, non-investment grade debt.

Bloomberg Barclays Emerging Markets Bond Index is broad-based with country eligibility and classification as an Emerging Market being rules-based and reviewed on an annual basis using World Bank income group and International Monetary Fund (IMF) country classifications.

Bloomberg Barclays U.S. Municipal Index is a rules-based, market-value-weighted index engineered for the long-term tax-exempt bond market.
