Week ending July 14, 2023

This week's economic data seemed to signal slowing inflationary pressure in the U.S. The Consumer Price Index (CPI) showed a year-over-year increase of 3.0% in June, down from the previous reading of 4.0% in May. Later in the week, the Producer Price Index (PPI) was relatively unchanged in June, with an increase of 0.1%. While the CPI reading is still above the Federal Reserve's target of 2.0%, this month's reading represented the lowest CPI increase since March 2021.

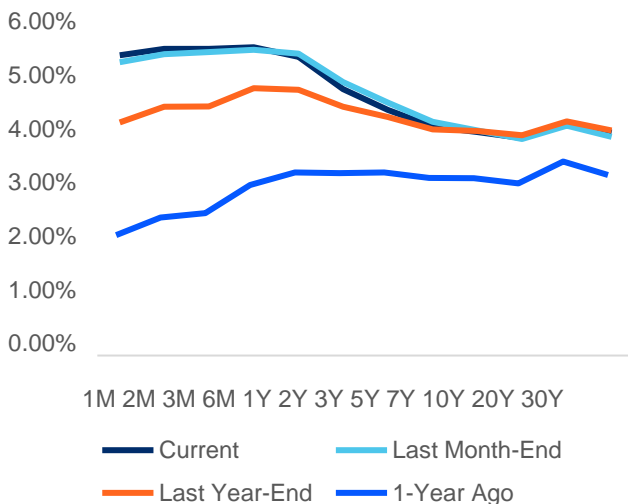
Fixed Income Markets Overview

- Bond yields had a volatile week, first falling after the CPI news, but rose on Friday after Fed Governor Waller stated that he still believes the Fed should stay the course and plan on two more rate increases this year.
- Despite the positive news on the inflationary front, the market seems to still be pricing in a rate hike at the next FOMC meeting on July 26th. The CME FedWatch Tool showed a rate hike probability of 96.1% as of Friday's close.

- All three major equity indices were higher for the week, boosted by the signs of lower inflation.
- All 11 of the S&P 500 sectors were positive for the week, led by Communication Services and Consumer Discretionary which were both up over 3.00%.
- Equities were higher early on Friday following positive earnings reports from JP Morgan, Wells Fargo, Citigroup, and United Health. However, the Nasdaq and S&P 500 fell into negative territory by the end of the day.

The index covers the U.S. investment grade fixed rate bond market, with index components for government and corporate securities, mortgage pass-through securities, and asset-backed securities.

Bloomberg US TIPS Index consists of Inflation-Protection securities issued by the U.S. Treasury.

Bloomberg Barclays U.S. Corporate High Yield Index covers the universe of fixed rate, non-investment grade debt.

Bloomberg Barclays Emerging Markets Bond Index is broad-based with country eligibility and classification as an Emerging Market being rules-based and reviewed on an annual basis using World Bank income group and International Monetary Fund (IMF) country classifications.

Bloomberg Barclays U.S. Municipal Index is a rules-based, market-value-weighted index engineered for the long-term tax-exempt bond market.

Bloomberg Barclays US High Yield Municipal Index is an unmanaged index of noninvestment-grade municipal debt securities, which provides a representation of the performance of US high-yield tax-exempt bonds.

Federal Funds Rate is the interest rate at which depository institutions trade federal funds (balances held at Federal Reserve Banks) with each other overnight.
